

SSRC NEW ADULT MEMBERSHIP **1st April 2021– 31st March 2022**

Good news: Adult membership fees for 2021/22 remain unchanged at £150, as do those for young rowers at £25 AND we can start rowing again at the start of the new membership year!

We have introduced a new Family Membership providing a small saving for 2 adults with more than one child, and we continue to offer half the adult membership at £75 for full time students over 18 and our more mature rowers aged 70 and over.

Not so good news: You will not be surprised that last year was a bad one, not only for rowing activities but also for club finances, with most fundraising events cancelled due to COVID 19. Sadly, the pandemic has a continued effect this year with our 2 main fundraising events cancelled already.

For these reasons the Trustees ask that if you are able to do so, you pay the full annual membership fee in April this year, rather than by monthly standing order, so that we can better manage our financial commitments and cash flow.

Each of these forms needs to be completed by you, signed in hard copy, addressed to the Membership Secretary and posted in the gig shed office door / handed to a current member. If taking the Family Membership, please complete one adult or young rower form for each person.

I have also included a membership form for the 1000 club should you wish to gain the chance to win monthly cash prizes and support the club funds.

Your membership payment enables Swanage Sea Rowing Club to pay its running costs including maintenance and replacement of rowing equipment and the gig shed, which in turn enables Swanage Sea Rowing Club to meet its charitable objectives all year round. The continued existence of the Club depends on your payments, together with other money derived from donations and fundraising activity, including the 1000 Club.
